A C RULE A-7

"ON" premise locations found to be within the restricted measurements will be required to provide the inventory receipts of food sales, not including beer sales. The food sales must consists of at least 40% of gross sales within six (6) months after opening.

A C RULE B-4

For "ON" premise establishments, where the food sales shall consist of less than 40% of the gross sales, said establishments shall be located no less than 500 feet (measurement along the center of the street) or within a 250 foot radius in any other direction, from the property line of any single family duplex residential property zoned R-S or R-D, or any church or school.

A C RULE C-1

All licenses must be current and prominently displayed at all times.
